THIS AGREEMENT shall be known as the Veolia Environmental Services (Australia) Pty Limited NSW Carriers' Interim Rates and Fuel Agreement 2012.

1. Application

This Agreement shall apply to all Contract Carriers engaged by Veolia Environmental Services (Australia) Pty Limited in its Solid Commercial Waste Division providing transport and cartage services for the collection and removal of waste in the Sydney Metropolitan Region currently operating out of Arndell Park and such other locations that this Division may operate from time to time.

2. Parties Bound

This agreement shall be binding upon:

- 2.1 Veolla Environmental Services (Australia) Pty Limited (the "Company"); and
- 2.2 The Transport Workers Union of New South Wales (the "Union"); and
- 2.3 Contract Carriers engaged by the Company providing the services referred to in clause 1 above.

3. Operation and Term

This Agreement shall commence to operate on and from the date of approval of this Agreement and shall have a nominal expiry date of 12 months from that date or until the date upon which a new agreement between the parties is approved whichever first occurs.

4. Interrelationship with other industrial instruments

This Agreement sets out the entire terms and conditions of engagement of Contract Carriers by the Company in respect of subcontractor rates of pay and interim fuel variations and operates in respect of subcontractor rates of pay and interim fuel variations to the exclusion of any other pre-existing contractor agreement or contract determination, including but not limited to the Veolia Environmental Services (Australia) Pty Limited NSW Carriers' Agreement 2009 and any applicable Contract Determination made under Part 3 of

Chapter 6 of the NSW Industrial Relations Act 1996 but only in respect of that subject matter and not otherwise.

5. Rates

- 5.1 The Company shall pay each Carrier for each job performed in accordance with the cartage rates specified in column 2 in the Schedule attached to this Agreement Inclusive of any CPI adjustment for the year ended 30 June 2012 and inclusive of the first fuel price increase point referred to in clause 5.3(e) below.
- 5.2 There will be no further annual adjustments of such rates by the CPI less fuel component (All Groups Sydney) before 1 July 2013.
- 5.3 The Company will irrevocably release and forever discharge the Contract Carriers and the Union in respect of any claims or costs of whatsoever nature arising from the Memorandum of Understanding between the Union and the Company and the implementation of the decision of Commissioner MacDonald of 23 March 2012 in proceedings before the New South Wales industrial Relations Commission being matter number IRC 798 of 2011. This clause may be pleaded as a bar to any proceedings brought by the Company with regard to any claims or costs of whatsoever nature arising from the Memorandum of Understanding between the Union and the Company and the implementation of the decision of Commissioner MacDonald of 23 March 2012 being matter number IRC 798 of 2011.
- 5.4 Any interim fuel variations will be deaft with on the basis of the following formula:
 - (a) The benchmark fuel price for the purpose of application of this rise and fall formula will be the wholesale fuel price (exclusive of GST) of fuel supplied to Contract Carriers at the Arndell Park depot (including freight cost to site);
 - (b) The base yard rate price of diesel fuel is agreed as \$1,05 per litre (exclusive of GST);
 - (c) The yard rate price of fuel as at the week ending 16 October 2012 was \$1.27;

- (d) The fuel rise and fall formula will be applied at the beginning of each quarter based on the average fuel price for the previous quarter;
- (e) The first fuel price increase point at which a 2% increase in contract carriers rates is payable is \$1.16 per litre (exclusive of GST);
- (f) Thereafter 2% increases in contract carriers rates are payable for each increase in the price of fuel of 20 cents per litre above \$1.16 per litre (exclusive of GST). To avoid doubt the second 2% increase in rates is payable when the price of fuel reaches \$1.36 (exclusive of GST). The third 2% increase is rates is payable when the price of fuel reaches \$1.56 per litre (exclusive of GST);
- (g) The same trigger points will apply in the event of decreases in fuel prices in which case there will be a 2% decrease in Contract Carriers' rates as and from the beginning of the following quarter.
