ENTERPRISE AGREEMENT 1999

Clause 1 - Parties to the Agreement and Title 1.

This agreement is made between Canterbury Community Child Care Centre (the employer) and the NSW Independent Education Union (IEU) a registered union of employees and will be known as Teachers Canterbury Community Child Care Centre Enterprise Agreement.

Clause 3 - Application and Operation 3.

- This agreement shall apply to teachers employed at Canterbury Child Care Centre, 50 King Street, 3.1 Ashbury
- 3.2 This agreement will operate for a period of twelve months from the date of registration.

Clause 4 - Award 4.

Except as provided by this agreement, the conditions of employment of teachers, shall be in accordance with the provisions of the Teachers (Non Government Pre Schools) (State) Award.

5. Clause 5 - Salaries

- This clause replaces the salaries and allowances set out in Tables 1 and 2 respectively of Part B Monetary (a) Rates of the above award.
- The rates of pay and allowances, as set out in Attachment 1 shall apply as a minimum from the beginning (b) of the first full pay period on or after 1 January 1999 and from 1 July 1999.

Clause 6 - Disputes Settling Procedures 6.

- 6.1 Where a dispute arises regarding the interpretation or application of any provision of this Agreement, or the actions of either party in relation to the operation of this Agreement, the procedures set out in this Registered clause will be followed. Enterprise Agreement
- 6.2 In the first instance the teacher and employer will attempt to resolve the matter.

Industrial Registrar

- 6.3 If the matter is not resolved at this level, the teacher may refer the matter to the IEU who will discuss the matter with the employer or his/her nominee.
- Where the procedures set out in 6.2 and 6.3 have failed to resolve a dispute, either party to this 6.4 Agreement may refer the matter to the Industrial Relations Commission for resolution.
- 6.5 Pending the outcome of the procedures contained in this clause, normal work will continue and neither party to this Agreement will take any action to aggravate the matter in dispute.
