TITLE

1. This Agreement is the Macquarie Generation Enterprise Agreement 2005.

DECLARATION

3. We declare that this Agreement:

Is not contrary to the public interest Is not unfair, harsh or unconscionable Was not entered into under duress Is in the interest of the parties.

SCOPE AND DURATION

- 4.1 This Agreement applies to all employees of Macquarie Generation who are covered by the current Macquarie Generation Employees (State) Award.
- 4.2 This Agreement will be effective on and from the date of approval by the Industrial Relations Commission of New South Wales and will remain in force for a period of 3 years.

RELATIONSHIP TO OTHER AWARDS AND AGREEMENTS

5. This agreement shall be read and interpreted in conjunction with the current Macquarie Generation Employees (State) Award ("The Award"). The provisions of this agreement will prevail over the provisions of The Award that deal with the same matters, to the extent of any inconsistency.

RETIREMENT AND SICK LEAVE

6.1 If Macquarie Generation decides to retire an employee because of ill-health, then they must do so under the relevant terms of The Award and, either:

- (a) the retirement must begin only after the employee has exhausted all sick leave credits; or
- (b) the employee must be paid any accrued sick leave outstanding.

Employees will not be granted any additional sick leave after Macquarie Generation decides that they are to be retired ill-health. Wherever practicable, 14 days' notice of the intention to retire will be given to the employees concerned.

6.2 Only employees who are retired because of ill-health are entitled to be paid for accrued sick leave.
