## 1. TITLE

## 3. OBJECTIVES OF THE AGREEMENT

#### **ALLOWANCES** 6.

The percentage increase and period in 5.1 will also apply to :

Meal Allowance and First Aid Allowance.

#### PARENTAL LEAVE 8.

Parental Leave - incorporating Maternity Leave, Paternity Leave and Adoption Leave. See the Industrial Relations Act 1996 (NSW), Part 4 of Chapter 2.

#### FAMILY LEAVE 9.

See the State Personal/Carers Leave Case of August 1996.

#### 10. NO EXTRA CLAIMS

if December It is acknowledged that this agreement expires on Nevember-30 1997, that negotiations for a new agreement effective December 1 1997 will commence three (3) months prior to that date and that no further claims will be made by any party to the agreement during the currency of this agreement.
