This Agreement shall be known as the A E Baker [Clerks] Enterprise Agreement - 1997.

3. INCIDENCE AND PARTIES BOUND

This Enterprise Agreement is made pursuant to Chapter 2, Part 2, Division 1 of the N S W Industrial Relations Act, 1996, entered into on the 14/1/1997 between J Blackwood and Son Limited, trading as A E Baker & Co and located at 3-9 Forge Street, Blacktown, 2148 and the employees classified as clerks, telephone sales clerks engaged to work in both the sales office and the warehouse departments.

4. TERM OF AGREEMENT

This Agreement shall have a nominal term of 12 months.

5. RELATIONSHIP TO PARENT AWARD AND AGREEMENT

It has been determined by the parties to this Enterprise Agreement that the agreement shall:

- Be read and interpreted wholly in conjunction with the Clerical and Administrative Employees [State] Award; and Registered
- [ii] Also be read and interpreted in conjunction with the currently registered Enterprise Agreement, approved on [Matter No. IRC 248 of 1997], and

provided that where there is any inconsistency, this Enterprise Agreement shall take precedence.

6. DURESS

This Enterprise Agreement has not been entered into under duress by any of the parties.

7. PURPOSE OF AGREEMENT

The purpose of this Agreement is to continue to pursue the aims of and to be identical to those as stated in the A E Baker Enterprise Agreement No.1 [Registered No. EA96/95] and the A E Baker [Clerks] Enterprise Agreement - 1996 [IRC 248 of 1997].

8. WAGE ADJUSTMENTS AND RATES

All clerical employees will be granted a wage increase of 4.0% on their actual rate of pay as at 1 October 1997, subject to the overall acceptance of the company pay offer and prior to registration by the Industrial Relations Commission of NSW.

9. NO EXTRA CLAIMS

The parties to this agreement acknowledge that there shall be no further claims for wage increases or any further claims during the nominal term of this agreement.

10. OPERATIVE DATE

Employees party to this agreement at the time of signing acceptance will be paid the appropriate wage adjustment from the 1 October 1997 in accordance with the terms of clause 8 herein.

Whilst the effective operative date will be the date of registration by the Industrial Relations Commission of NSW, the employer undertakes to arrange further enterprise agreement discussions with staff party to this agreement on or before 1 October 1998.
